Terms and Conditions:-

- The bidder shall quote consolidate lump-sum rates of all the material as tabulated in Annexure enclosed. Material can be inspected in the office of Principal Accountant General (A&E) on any working day from 10 AM. to 5 PM. by contacting the official concerned on Mobile No. 8219162774
- 2. Bidders should submit Rs.10,000/- as EMD (refundable to unsuccessful bidder) in the form of Demand Draft payable to "Principal Accountant General (A&E) Himachal Pradesh Shimla."
- 3. The successful bidder shall pay the amount within two days after opening of bids failing which the bid shall be cancelled and EMD shall be forfeited as per the discretion of the Principal Accountant General (A&E) Himachal Pradesh Shimla.
- 4. The material shall be lifted at the successful bidder's own cost (inclusive of labour, transport, packing material etc.) within two days after making the payment of bid amount, failing which demurrage charges shall be levied at the rate of Rs.1,000/- Per day. If the material is not lifted within one week after payment of the successful bid amount, the bid shall be cancelled and no refund of the amounts paid shall be given.
