#### **Tender Notice for Annual maintenance of ROs cum water coolers**

Sealed Tenders are invited from the local firms for annual maintenance of RO cum water coolers in the office of the Principal Accountant General (Audit-I) Madhya Pradesh, Gwalior, Audit Bhawan, Jhansi Road, Gwalior. The sealed tenders may be addressed to Sr.Deputy Accountant General (Administration), office of Principal Accountant General (Audit-I) Madhya Pradesh, Gwalior. The sealed tender may be submitted in his chamber on any working day on or before 20-02-2024 (3.00PM). The tender received late will not be considered. Any delay on the part of the postal authorities will be the sole responsibility of the tenderer.

- 5 All disputes and differences arising out of/or in connection with this order shall be subject to the exclusive jurisdiction of courts at Gwalior.

#### **Terms and Conditions:-**

- 1. The rates should be quoted for the comprehensive maintenance of the RO Annexure "B" attached. including its repairs, replacement of all the faulty parts for and its immediate rectification such as pre filter, sediment filter, pre carbon block, post carbon block, particulate filter, compressor and all electrical parts. (Nos of ROs- Kent Elite ROs-08 Nos, Aqua guard hot and cold 40 ltrs RO-02 Nos, RO domestic 20 ltrs-07 Nos.)
- 2. The contract period of ROs shall be from 01-04-2024 to 31-3-2025
- 3. The office may increase or reduce the number of ROs. (Kent Elite, Hot & Cold, Domestic) as per the convenience.
- 4. The bidder should have their registered office or branch in Gwalior (MP).
- 5. AMC payment will be released in four installments after successful completion of 3 months period.
- 6. The office has full right to cancel the tender without assigning any reason to the bidders.
- 7. Conditional tenders shall not be accepted.
- 8. The rate tendered by bidder/firm shall be inclusive of GST. No increase on any account would be accepted by this office.
- 9. The bidder/firm should be registered with GST authorities and must be in possession of PAN. The documentary proof in this regard should be attached along with their bids.
- 10. The firm should have previous experience in maintenance of RO cum water coolers. Copies of experience are to be enclosed along with their bids.
- 11. The faulty items once replaced, the same should be handed over to the office by the firm.
- 12. All the items related to RO replaced will be company approved materials.
- 13. Corrective maintenance will be carried as and when the complaints are registered with the firm in writing or on phone. The faults should be rectified by the same day or on the next day of the date of complaint.
- 14. In case of failure to rectify the complaint within 24 hours, an amount of Rs 500/- will be deducted per day from the AMC bill payable to the firm.
- 15. The successful bidder shall require to furnish a Performance security of Rs 10,000/- (Rupees ten thousand only) through FDR in favour of Principal Accountant General (Audit-I) MP, Gwalior immediately after the work is awarded.
- 16. Earnest Money Deposit (EMD) of Rs 5,000/- in the form FDR in favour of Principal Accountant General (Audit-I) MP, Gwalior is to be furnished along with the bid.
- 17. The bidders are advised to visit the office during any working days to check all ROs.
- 18. The bid of any bidder not complied with the conditions prescribed above will be summarily rejected.
- 19. The performance security shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations.
- 20. The AMC is for one year, but it may be extended for further period subject to the satisfactory performance and the willingness of both parties.
- 21. All disputes and differences arising out of/or in connection with this order shall be subject to the exclusive jurisdiction of courts at Gwalior.
- 22. The office reserves the right to accept or reject any tender/all tenders in full or in part without assigning any reason whatsoever.
