# 3. Terms and conditions

- (i) Only reputed brands like Dahua, Hikvision, CP-Plus or any other brands as approved by this office will be entertained.
- (ii) The bidder participating in the tender should be experienced in undertaking works of the above nature.
- (iii) The bidder should have a service facility in Thiruvananthapuram headed by professionally qualified person. The name, address, contact number of the service personnel should be provided to this Office.
- (iv) The firm/ bidder should offer warranty for the supplied items for a period of not less than one year. Preference will be given to those who offer more warranty period.
- (v) The maximum period for the service provider to attend in case of complaints/breakdown should be 48 hours during warranty period.
- (vi) While scrutinizing & evaluating the bids, the Office shall take into consideration the following aspects:
  - (a) The best quality specified in terms of standard, latest technology, specification of equipment used, best facilities provided within the specified items etc.

- (b) After sale service provided by the bidding agency & warranty.
- (vi) Deputy Accountant General (Admn) has the right to reject any or all the quotations.

#### 4. Quoting the Rate

- (i) Bidders shall quote a lump sum rate for the whole work which includes applicable taxes, transportation, installation charges, risk factors, commissioning of the project etc.
- (ii) The quote shall be supported with clear technical specifications on each item used for execution of the work.
- (iii) The bidders have to visit the Office on working days, evaluate the requirements in consultation with the undersigned so as to provide the best available system in terms of technical specifications, quality, estimate amount etc.

# 5. Time Schedule for execution of the work

The successful bidder shall execute and complete the work as per specification/scope of the work to the satisfaction of this Office within a period of 15 working days from the date of award of the contract. The successful bidder to whom the work is awarded shall have to execute the work as per the work order and the terms & conditions of this tender document.

## 6. Bid security and performance security.

All bidders who quote for the assignment shall enclose with the quotation a DD of 2% of the bid amount, drawn in favour of 'Pay and Accounts Officer, Office of the Accountant General (A&E), Kerala as bid security. After completion of the quotation processes, the bid security of unsuccessful bidders will be returned by speed/registered post. The bid security of the successful bidder will be retained by this Office till a performance security, which is 5% (rounded off to the next thousand) of the value of the contract as specified in the bid document is furnished and agreement executed. Performance security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.

## 7. Payment Terms and other Conditions.

Bills shall be passed for payment only after completion and commissioning of the project satisfactorily in terms of the conditions stipulated in the work order and in tune with the terms and conditions of this quotation notice.

No advance payment will be made to the successful bidder. Payment will be made in lumpsum through e-payment, on completion of work. Any damage to the Office buildings, property etc during the execution of work shall be compensated by the successful bidder from the bills thus submitted. TDS at applicable rate shall be deducted while making payment to the successful bidder.
