Eligibility Criteria

- 1. The bidder should have supplied a similar work order during the last three years and the proof (Work order/Client Certificate) should be submitted along with the tender submission.
- 2. The bidder should have functional offices in Thiruvananthapuram, Kochi and Thrissur with support engineers in their payroll.
- 3. EMD of Rs.25,000/- (Rs. Twenty-Five thousand only) in a Demand Draft in favour of Pay & Accounts Officer, O/o the Accountant General (A&E) Kerala Thiruvananthapuram.
- 4. Registration Certificate along with GST details.
- 5. Escalation Matrix of the bidder support team.
- 6. ISO certification of the bidder.
- 7. Manufacturer Authorization Form.

Terms and conditions

- 1. Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 2. Bidder should have functional offices in Kerala at Thiruvananthapuram, Kochi & Thrissur with support engineer in their payroll.
- 3. The seller should have an active Toll-Free Number.
- 4. Bidder should be ISO certified.
- 5. A valid Bid Specific Manufacturer's Authorization Form Certificate is to be submitted.
- 6. Actual delivery (and Installation & Commissioning (if covered in scope of supply)) is to be done at Office of the Accountant General (A&E), Kerala M G Road, Statue Junction, Thiruvananthapuram 695001.
- 7. Net Worth of the OEM should be positive as per the last audited financial statement.
- 8. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 9. The bidder or the OEM of the offered products must have ISO 9001 certification.
- 10. The bidder is required to upload, along with the bid, all relevant certificates such as BIS license, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
- 11. Minimum Average Annual Turnover of the bidder (For 3 Years) should be seven lakh rupees.
- 12. Minimum Average Annual Turnover of OEM (Last 3 Years) should be fifty six lakh rupees.
- 13. There should be a minimum of three years of experience in same service.
