3. Details of EPABX system-

- 4. The rates tendered by the bidder/ firm shall be inclusive of GST. No increase on any account would be accepted by this office.
- 5. The bidder should have their registered office or branch in Gwalior (MP).
- 6. The bidder/firm should be registered with GST authorities and must be in possession of PAN. The documentary proof in this regard should be attached along with the bid.

- 7. The firm should have previous experience of at least five years in maintenance of EPABX system. Copies of experience are to be enclosed along with the bid.
- 8. Conditional tenders shall not be accepted.
- 9. Corrective maintenance will be carried as and when the complaints are registered with the firm in writing or on phone. The faults should be rectified by the same day or on the next day of the date of complaints. The service provider will install any new phone lines that are needed without charging for labor or services.
- 10. Any breakdown in the system should be rectified within 24 hours of registering the complaint. In case of failure to rectify the complaint within 24 hours, an amount of Rs. 500/- will be deducted per day from the AMC bill payable to the firm.
- 11. All the items related to EPABX replaced will be of standard quality with ISI/BIS mark.
- 12. The faulty items once replaced, the same should be handed over to the office by the firm.
- 13. The technical person (s) must have an identity card and must wear it while on duty in this office. The identity card must be visible to make it easy to identify the technical person.
- 14. The technical person shall make his entry in the entry register kept by Caretaker/ Receptionist.
- 15. Earnest money deposit (EMD) of Rs. 10000/- (Rupees ten thousand only) in the form of FDR in favor of Principal Accountant General (Audit-I), MP, Gwalior is to be furnished along with the bid.
- 16. The bidders are advised to visit the office during any working days to check the EPABX system and line layout.
- 17. The bid not complying with the conditions prescribed above will be summarily rejected.
