# Sub: Tender for Annual Maintenance Contract of Air Conditioner machines

## The details of Tender are as summarized below:-

- A) Name of Work: Comprehensive Annual Maintenance of window and split air conditioners installed at O/o the Director General of Audit (Central), Kolkata.
- B) Pre-Qualification Requirement (PQR) of bidders eligibility criteria for the issue of the Tender document are as under:
  - i. Reputed AC manufacturers/ or their authorized dealers / or their authorized Service providers are eligible to participate.
  - ii. Should have well established servicing facility in Kolkata
  - iii. At least three years Experience in the field of AMC of Air Conditioning machines. **Director**General of Audit (Central), Kolkata reserve the right to call for documentary proof, if required.
  - iv. Trade License Certificate should be furnished.
  - v. Xerox copy of latest Income Tax certificate, Goods & Services tax certificate and Xerox copy of PAN card should be furnished.
  - vi. Tender form can be downloaded from our web site pdackolkata.gov.in from 06.07.2021 onwards.
  - vii. Tenders in a closed envelop with all documents relating to Pre-Qualification requirement superscripting "AMC of Air Conditioning machines" should reach this office either by Speed post/hand delivery latest by 20.07.2021 upto 01.00 pm. Tenders received after due date and time will not be entertained/considered.
  - viii. Tender will be opened on 20.07.2021 at 03.00 pm at the O/o the Director General of Audit (Central), Kolkata.

### **General Terms and Conditions:-**

1. Tender shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected.

- 2. The service provider shall provide direct service and shall not employ Sub- Contractors.
- Sealed quotations are invited for the Annual Maintenance contract of 35 (thirty five) no. of Split
  AC machines of different capacities as mentioned in Annexure-I for the period from 01.08.2021
  to 31.07.2022.
- 4. The Agencies can inspect the site and equipments, after taking prior approval between 10am to 5 pm on all working days. No extra cost shall be payable for non awareness of the site/equipments conditions and constraints.
- 5. Corrections, if any in the tender form must be attested by the tenderer.
- **6. Director General of Audit (Central), Kolkata** reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.
- 7. Late tenders will not be considered and shall be rejected.
- **8.** All the spare parts including compressor and gas charging with inlet and outlet pipes attached with the A.C machine are to be included irrespective of type of machines.
- 9. The contract covers periodical servicing once in a month.
- 10. Necessary arrangement to depute service engineer in each month under the intimation to the Record-I section for preventive and remedial maintenance service to the 35 no.s A.C Machines (Annexure-I) is to be made during the entire contractual period.
- 11. All break down calls shall be attended within 24 hours of working days except holidays.
- 12. The time schedule given for attending breakdown call is 24 hours and if the machine is required to be moved to workshop for major repair which may take more than 48 hours to return, loan machine shall have to be provided without any extra cost. No transportation charges will be provided for that.
- **13.** Payment will be given on quarterly basis on one fourth of the total contract value, after completing the each quarter, after giving satisfactory services.
- 14. Tax at source will be deducted from each bill of the vendor as applicable under rules in respect of Income Tax Act, 1961/ G&ST Act. Etc.
- **15.** The contract is liable to be terminated at any time with a notice of **15** days and without assigning any reason to the bidder.
