Any delay on the part of the postal authorities will be the sole responsibility of the tenderer.

- The rates shall be quoted for the comprehensive maintenance of the RO cum water coolers including its repairs, replacement of all the faulty parts and its immediate rectification such as pre filter, sediment filter, pre carbon block, post carbon block, particulate filter, compressor and all electrical parts. (Nos of ROs-Aqua guard pure chill 80 pss 50 ltrs RO-09 Nos, Aqua guard hot and cold 40 ltrs RO-02 Nos, RO domestic 20 ltrs 7 Nos.)
- The bidder should have their registered office or branch in Gwalior (MP). 2.
- AMC payment will be released in four installments after successful completion of 3 months period. 3.
- If any new RO is installed or any RO is removed then proportionate payment will be made for the actual no. of ROs 4.
- Conditional tenders shall not be accepted. 5.
- The rate tendered by bidder/firm shall be inclusive of GST. No increase on any account would be accepted by this 6. office.
- The bidder/firm should be registered with GST authorities and must be in possession of PAN. The documentary proof 7. in this regard should be attached alongwith their bids.
- The firm should have previous experience in maintenance of RO cum water coolers. Copies of experience are to be 8. enclosed alongwith their bids.
- The faulty items once replaced, the same should be handed over to the office by the firm. 9.
- All the items related to RO replaced will be company approved materials. 10.
- Corrective maintenance shall be carried as and when the complaints are registered with the firm in writing or on phone. 11. The faults should be rectified by the same day or on the next day of the date of complaint.
- In case of failure to rectify the complaint within 24 hours, an amount of Rs 500/- will be deducted per day from the 12. AMC bill payable to the firm.
- Earnest Money Deposit (EMD) of Rs 5,100/- in the form of FDR/Account payee Demand Draft /Bank Guarantee in 13. favour of Principal Accountant General (Audit-I) M P, Gwalior is to be furnished alongwith the bid. The bid security is to remain valid for a period of 45 days beyond the final bid validity period.
- The bidders are advised to visit the office during any working days to check the all ROs. 14.
- The bid of any bidder not complying with the conditions prescribed above will be summarily rejected. 15.
- The successful bidder shall require to furnish a Performance security of Rs 25,000/- (Rupees Twenty five thousand 16. only) through FDR Bank Guarantee in favour of Principal Accountant General (Audit-I) MP, Gwalior immediately after the work is awarded. Performance security should remain valid for a 60 days beyond the date of completion of all contractual obligation of the supplier including warranty obligations.
- The contract document should be executed by the successful bidder within 21 days of the issue of letter of acceptance. 17. Non-fulfillment of this condition of executing a contract by the contractor or suppliers would constitute sufficient ground for annulment of the award and forfeiture of EMD.
- The resultant contract will be interpreted under Indian Laws. 18.
- The AMC shall be for one year, but it may be extended for period of two years subject to the satisfactory performance 19. and the willingness of the firm for such extension.
- All disputes and differences arising out of/or in connection with this order shall be subject to the exclusive jurisdiction 20. of courts at Gwalior.
- The office reserves the right to accept or reject any tender/all tenders in full or in part without assigning any reason 21. whatsoever.
