SECTION-III INSTRUCTIONS TO BIDDERS

Office of the Comptroller and Auditor General of India, New Delhi invites **online bids** for Disposal of dismantled material of HVAC Plant at 10, Bahadur Shah Zafar Marg, New Delhi-110124 under Open Tender Enquiry Method. The invitation to bids is open to all agencies fulfilling the eligibility criteria. Agencies not conforming to any of the following parameters will not qualify:

Eligibility Criteria:

- i. The Agency should have minimum three years' experience in the field of dismantling, lifting, removal and disposal of dismantled material, scrap, etc.
- ii. The Agency should be an Income Tax assesse and should have filed Return of Income for the last 3 assessment years, i.e. Assessment Years 2020-21, 2021-22 and 2022-23.
- The Agency is expected to examine all instructions, forms, terms & conditions, and specifications in the bidding document. Failure to furnish information required by the bidding document or submission of a bid not substantially responsive to the bidding document in each and every respect will result in rejection of the bid.
- The scrap/goods of dismantled material of HVAC plant will be sold on "as is where is basis", so far as the physical condition, quality and quantity of the same is concerned. That is to say, the Agency(ies) will be deemed to have made themselves aware of the physical conditions, dimensions, size, weight, conditions, quantity, etc. by inspecting the material before submitting their bids and no complaint/ claim in this regard will be entertained by the O/o the Comptroller and Auditor General of India, New Delhi after the submission of the tender.

4 TECHNICAL BID

The Bidder shall be required to follow the procedure as specified above and submit its bid (Technical and Financial) through online mode only as detailed in succeeding paragraphs. The following documents shall be required to be submitted/uploaded by the Bidder in support of their online Bid:

(4.1) The Bidder shall be required to print "Bid Submission Form' as per Section-II on Company's letterhead, sign, stamp, scan and upload on the CPPP portal.

- (4.2) The Bidder shall be required to sign, stamp, scan and upload the Technical Bid Form as per Section-VI along with other documents as specified in the tender document.
- (4.3) The bidders are required to upload scanned copy of Earnest Money Deposit (EMD) of ₹40,000/- by means of bank guarantee/demand draft pay/ banker's cheque drawn in favour of PAO, Office of the Comptroller and Auditor General of India payable at New Delhi, along with their bids. The EMD is to remain valid for a period of 90 days beyond the final bid validity period. In case the tender process takes longer than 90 days, the successful bidder will submit a fresh EMD of ₹40,000/- before the expiry of earlier instrument through which the EMD was furnished.
- (4.4) The original copy of the Earnest Money Deposit (EMD) should be sent to Sr. Administrative Officer (Admn.-II), Office of the Comptroller and Auditor General of India, 10, Bahadur Shah Zafar Marg, New Delhi on or before the time of closing of the uploading of the Bids. The original of the EMD can be sent by Speed Post or Registered Post. Physical copy of EMD can also be dropped in the tender box placed at Office of the Comptroller and Auditor General of India, 10 Bahadur Shah Zafar Marg, New Delhi or at Office of the Comptroller and Auditor General of India, 9, Deen Dayal Upadhyaya Marg, New Delhi 110 124. No acknowledgement for EMD dropped at tender box shall be provided. In the event of non-receipt of the EMD before the closing of the uploading of the Bids, the bid shall not be opened.
- (4.5) Bidders, who are eligible to be exempted from depositing EMD according to Rule-170 of GFRs, 2017, should submit documentary proof thereof along with technical bid. Besides, they have also to enclose a hardcopy of same valid exemption certificate(s) and ensure that the same is submitted to the officer in charge as Sr. Administrative Officer (Admn.-II), Office of the Comptroller and Auditor General of India, 10, Bahadur Shah Zafar Marg, New Delhi-110124.
- (4.6) Income tax Return for the last 3 assessment years, i.e. AYs 2020-21, 2021-22 and 2022-23 and copy of PAN.
- (4.7) The Bidder shall sign its bid with the exact name of the concern to which the contract is to be awarded.
- (4.8) The Bid document filed by the bidder shall be typed or written in indelible ink. No overwriting or cutting shall be permitted. No bid will be considered unless and until all pages/documents comprising of the Bid are properly signed and stamped by the persons authorized to do so.
- (4.9) In case, the day of bid submission is declared Holiday by Government of India, the next working day will be treated as day for submission of bids. There will be no change in the timings.
- (4.10) The Competent Authority reserves the rights to reject any or all bids without assigning any reason and the decision of the Competent Authority of the Office of the Comptroller and Auditor General of India, shall be final and binding.
- (4.11) All the bid documents uploaded shall be serially page numbered and contain the table of contents with page numbers.

5. FINANCIAL BID

(5.1) The Financial Bid shall comprise the price component for disposal through purchase of all scrap of dismantled material of HVAC plant (as is where is basis)

lying at 10, Bahadur Shah Zafar Marg, New Delhi-110124 indicated in the Section-VIII of the bid document.

(5.2) Rates quoted for dismantled scrap of HVAC plant 'as is where is basis' plus GST or any other statutory levies, if any, extra.

- (5.3) The bidder will have to bear the cost of lifting, removal, disposal of unserviceable dismantled material of HVAC plant lying at 10 Bahadur Shah Zafar Marg, New Delhi.
- (5.4) Price shall be quoted in Indian rupees only.
- (5.5) The Bidder shall sign its bid with the exact name of the concern to which the contract is to be awarded.
- (5.6) The Bid document filed by the bidder shall be typed or written in indelible ink. No overwriting or cutting shall be permitted.
- (5.7) The financial bid will be opened only for technically qualified firms.

6. **Opening and Evaluation of Technical Bids:**

- (6.1) The technical bids shall be opened by a committee of the officers constituted by the competent authority for the purpose at the time and date as specified in the tender document.
- (6.2) Statements, documents, proof of EMD etc. submitted by the bidders will be verified for technical evaluation. The technical bids shall be evaluated later to ensure that the bidders meet the minimum eligibility criteria as specified in the Tender Document.
- (6.3) Bids shall be declared as Valid or Invalid based on the preliminary scrutiny by the Tender Opening Committee. However, detailed evaluation shall be done only in respect of Valid Bid.
- (6.4) Failure to furnish EMD (in original) will result in bid getting rejected.

7. Opening and Evaluation of Financial Bids:

- (7.1) The Financial Bids of all the technically qualified Bidders, whose bids are accepted in conformity with the required specifications shall be opened on the appointed date and time in presence of the qualified bidders/ their authorized representatives, who choose to be present at the time of opening of the financial bids.
- (7.2) The Highest Acceptable Bid will be considered further for placement of contract after complete clarification.
- (7.3) If there is a discrepancy between words and figures, the amount mentioned in words shall be taken as the bid price. If the bidder does not accept the correction of errors, as aforesaid, his bid will be rejected.
- (7.4) In the event of more than one bidder with the heights bids (say equal), the bidder with the highest 'cumulative annual turnover of the last 3 financial years would be deemed as 'Successful Bidder' with respect to the submission of proof of documents as submitted by the bidder.

8. RIGHT OF ACCEPTANCE:

(8.1) The Office of the Comptroller and Auditor General of India reserves all rights to reject any bids including of those bidders who fail to comply with the

instructions without assigning any reason whatsoever and does not bind itself to accept the highest or any specific bids. The decision of the Competent Authority of the Office of the Comptroller and Auditor General of India in this regard shall be final and binding.

- (8.2) Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the work shall render the bidder's bids liable for rejection.
- (8.3) The competent authority of the office of the Comptroller and Auditor General of India reserves the right to award any or part or full contract to any successful agency (ies) at its discretion and this shall be binding on the bidders.
- (8.4) In case of failure to comply with the provisions of the terms and conditions mentioned, by the agency that has been awarded the contract, the competent authority of the Office of the Comptroller and Auditor General of India reserves the right to award the contract to the next higher bidder or any other outside agency.
- (8.5) The office of the Comptroller and Auditor General of India shall terminate the Contract if it is found that the Contractor was black listed on previous occasions by any of the Government Departments / Institutions / Local Bodies / Municipalities / Public Sector Undertaking etc. In such case, the Contractor is also liable to be blacklisted by the Client.
- (8.6) The contractor shall not subcontract or permit anyone other than it to perform any of the work, service or other performance required of the Agency under the contract.

9. RETURNING OF EARNEST MONEY DEPOSIT (BID SECURITY AMOUNT)

- (9.1) The Earnest Money Deposit of the unsuccessful bidders will be returned within 15 days of financial evaluation of tenders.
- (9.2) The Earnest money deposit of all the bidders shall be returned in case of cancellation of Tender after the opening of Bids and prior to opening of financial bids.
- (9.3) No interest shall be paid on Earnest Money Deposit.

10. **Prior to the submission of Bid**

The Bidder/ authorized representative shall personally inspect the first at his own cost and under prior intimation to the Caretaker, 10, Bahadur Shah Zafar Marg, office of the Comptroller and Auditor General of India, New Delhi. - 2. This office does not bind itself to accept the highest offer and reserves the right to reject any or all the bids received without assigning any reason whatsoever it may be.
- 3. After determining the successful bidder, Client shall issue a Letter of Acceptance (LoA) in duplicate, who will return one copy to Client duly acknowledged, accepted and signed by the authorized signatory, within Three (3) days of receipt of the same by him.
- 4. The successful bidder within five days of the acceptance of the LoA shall execute a Performance Bank Guarantee in the form of a Bank Guarantee of any nationalized bank, a sum of ₹80,000/- (Rupees eighty thousand) in favour of Pay and Accounts Officer, Office of the Comptroller and Auditor General of India, New Delhi, payable at New Delhi.
- 5. The Agency will be responsible for the execution of entire work and will be legally liable for any harm or loss arising to any person whomsoever, in whatever form, from any act of negligence, omission or commission, whether intentional or otherwise, of the contractor or any of the workers/agents deployed by the contractor in the course of providing any services stated in this contract, and will bear full responsibility and cost of the same. - 8. In case the selected bidder does not remove the scrap within stipulated time period, the bid security/performance bank guarantee shall be forfeited in full or partially and re-sale of the items shall be made at the risk and cost, if any, of such defaulter, which will be adjusted from the security deposit. Decision of the competent authority of this office shall be final in this regard and binding on the bidder.

- 9. This office shall have full right to forfeit the EMD partially or in full in any case, the successful bidder fails to comply the instructions of this office or withdraw bid at any stage or breaches any of terms & conditions of the tender enquiry or acceptance letter.
