- 2. The bidders should have valid GST registration and PAN card. Supporting photocopies should be attached.
- 3. All the intending vendors have to deposit Rs.7,000/- only in the form of Demand Draft drawn in favour of PAO (Audit) O/o the Principal Accountant General (A&E), West Bengal, Kolkata- 700001 as Earnest Money Deposit (EMD).
- **4.** The AMC rate along with spare parts (inclusive all taxes) once furnished and accepted by this office cannot be changed by the firm during the contractual period. Any request in this regard will not be entertained.
- 5. During contractual period, if any machine is required to be taken in the workshop, the carrying cost will not be borne by this office.
- **6.** Payment will be made in two equal installments (i.e. half yearly basis) after performing satisfactory service.

- 7. All breakdown calls shall have to be attended within 24 hrs and restored within 48 hours. Otherwise as a measure of penalty @1% of the contractual value per machine against every delayed day/s will be deducted during payment.
- 8. The vendor will not be allowed to sublet any service work (partially or entirely) to any other vendor at its own cost.
