#### B. Eligibility/ Qualification Criteria:

- a) The bidder should be registered with Central Pollution Control Board or State Pollution Control Boards in terms of E-Waste (Management Rules) 2016.
- b) The firm may enclose sufficient documents regarding execution of Government work order, specifically Disposal of e-waste.
- c) Period of validity of bid:-

The bid shall remain valid for 30 days after the date of bid opening. If any bidder withdraws his tender before the said period shall without prejudice to any other right or remedy, be at liberty to cancellation of the bid.

#### D. General Terms and Conditions:

- The bidder may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for by examining the items condition on "As is where is basis".
- The items shall be sold to the highest bidder. The selected bidder is liable to lift all the items listed in the respected annexure irrespective of whether the items have been marked with base price or not.
