Notice Inviting Quotation

This office intends to engage a reputed firm for the general pest control treatment in all sections of this office housed in all the three buildings of Treasury Buildings Complex at 2 no Govt. Place and 8 no Kiran Sankar Roy Road and five rooms at 1 no Council House Street once in each month for one year. Intended bidders should visit all the sections of this office before quoting rates for the general pest control treatment. Vendors are requested to quote their rates for the said job subject to the adherence of the terms and conditions given below.

Terms & Conditions:

- 1. Participant bidders should have adequate experience (at least two years) in general pest control treatment in govt. (Central/State/Undertaking etc.) offices. The bidders should have enough expertise, capability and equipments in this aspect. Proof should have to be attached.
- **2.** The bidders should have valid Trade licence, GST registration and PAN card. Supporting photocopies should be attached.
- 3. All the intending vendors have to deposit Rs.1,000/- only in the form of Demand Draft drawn in favour of PAO (Audit), O/o the Pr. Accountant General (A&E), West Bengal, Kolkata- 700001 as Earnest Money Deposit (EMD).
- **4.** The rates (inclusive all taxes) once furnished and accepted by this office cannot be changed by the firm during the contractual period. Any request in this regard will not be entertained.
- **5.** The general pest control treatment must be done once in a month in the following buildings
 - i) Treasury Buildings, 2nd Government Place(West), Kolkata 700001.
 - ii) G.I. Press Buildings, 8 Kiran Shakar Roy Rooad, Kolkata 700001.
 - iii)Manager's Bunglow, 8 Kiran Shakar Roy Rooad, Kolkata 700001.
 - (iv)Five rooms (106, 111, 119,120,121) of this office at Counsil House Street.
- **6.** Payment will be made in four equal installments (i.e. quarterly basis) after performing satisfactory service.
- 7. The vendor will not be allowed to sublet any service work (partially or entirely) to any other vendor at its own cost.
- **8.** EMD will be converted into Security deposit in case of successful bidder which will be refunded after six month on completion of general pest control treatment period satisfactorily.
