- 5) Before Printing and Supply, the final proof of the Magazine is to be got approved and checked by Hindi Officer/Admin Hindi Cell.
- 6) If any defect is noticed particularly in case of quality of the paper and workmanship, the selected vendor will be liable for immediate replacement of the defective articles at his own cost.
