2 Sealed quotations are invited for the disposal of the aforesaid vehicle on the terms and conditions mentioned below. Interested persons/agencies to buy the aforesaid Car are required to submit their quotations in the enclosed proforma, in a sealed envelope superscripted as "Tender for Disposal of Old Car", addressed to the Principal Accountant General(A&E) I Maharashtra Mumbai,Pratishta Bhawan, 101 M K Road Mumbai 400020 from 9.30am to 5.30 pm on or before 11th Feb 2021. The quotations received will be opened by the Committee constituted for this purpose on 12th Feb 2021 at 11.00am. The Vehicle is available for inspection from 8th Feb 2021 to 11th Feb 2021 on all working days from 11.00am to 4.00 pm.

3 The interested bidders may submit their bid application alongwith an Earnest Money Deposit of Rs4000/ by way of Demand Draft in favour of Principal Accountant General(A&E) I Mah Mumbai,.

4 Tender form filed in pencil, overwritten, illegible or erased will not be considered.

5 Only the quotations received in time will be opened on 12th Feb 2021 at 11.00am .

6. Any offers received without the Demand draft and with incomplete proforma will not be considered

7. The sale will be governed by the following conditions:
- i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs4000/ by Demand draft in favour of Principal Accountant General (A&E) I Mah Mumbai within 3 days of intimation. The delivery of the sold vehicle will be given only after the successful bidder submits the Demand draft and documentary evidence in support of residential status(Aadhar Card in case of Individual and Registration Certificates in case of firms etc)
 - ii) The EMD will be forfeited in case the successful bidder fails to make the balance payment of vehicle within the stipulated time.
 - iii) The EMD will be returned to the unsuccessful bidder after the acceptance of the offer by the successful tenderer. However, no interest shall be payable on the EMD.
 - iv) The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses.
 - v) The vehicle will be disposed off on "as is where basis is" and no guarantee for its worthiness or quality will be given by this office.
 - vi) The successful bidder will also be responsible for getting the Registration certificate of the vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
 - vii) The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.
 - viii) After the date of possession of vehicle by the successful bidder, office will not be liable in any manner regarding its use and misuse.
 - ix) The Committee reserves the right to accept or reject any/all of the quotations without assigning any reason. The decision of the Competent Authority shall be final and binding.
 - x) The vehicle will be handed over to the bidder after he has completed all the formalities pertaining to the transfer of vehicle in his name and also produce the copies of the same in order to avoid misuse of the vehicle.
