1. **DEFINATIONS**:

Boldface type is used to identify defined terms.

- a) The PAG means Pr. Accountant General (A&E), Meghalaya, Shillong.
- b) The **Bidder** means the person/vendor/firm who is interested to submit thebids/quotations.

- c) Party means either the O/o The PAG (A&E) Shillong or the Bidder, as the context requires.
- d) The **Offer/Bid/Quotation/Tender** is the completed bidding documents submitted by the bidder to the O/o The Pr. Accountant General(A&E) Meghalaya, Shillong.
- e) The Letter of Acceptance means the formal acceptance by the PAG of the Bid.
- f) **Days** are calendar days, months are calendar months.

2. SCOPE OF WORK:

The O/o The Pr. Accountant General(A&E) Meghalaya, Shillong intends to dispose e-waste items as listed in Annexure-I on "AS IS WHERE IS BASIS" lying in the O/o The Pr. Accountant General(A&E) Meghalaya, Shillong as per the Central Pollution Control Board / State Pollution Control Board guidelines for disposing of such items.

3. ELIGIBILITY CRITERIA:

License from the Khasi Hills Autonomous District Council concerned of Meghalaya for Non-Tribal bidders

Tribal belonging to any of the Schedule Tribes pertaining to Meghalaya will be required to submit a self attested copy of their Schedule Tribe Certificate.

4. EARNEST MONEY DEPOSIT (EMD)

- i. Earnest Money deposit would be Rs. 11,000/- (Rupees Eleven thousand) only in the form of crossed Demand Draft/Pay Order/Banker's Cheque from any commercial bank in favor of "PAO, Shillong, O/o The Pr. Accountant General(A&E) Meghalaya, Shillong" payable at Shillong.
- ii. The Earnest Money deposit is refundable without interest for unsuccessful bidders only on completion of the entire process.
- iii. For the successful bidder who intends to take physical possession of the e-waste items, the Earnest Money deposited shall be adjusted with the balance amount to be paid by him / her accordingly.
- iv. The Earnest Money deposit of the successful bidder will be forfeited if the e-waste items quoted are not taken physical possession of by the successful bidder as provided in 7 (h) &(i) herein.
- v. No interest will be paid by this Office on the Earnest Money Deposit.

5. SUBMISSION OF BIDS:

Interested parties should submit their application bid form as per format enclosed as Annexure-II on or before 31^{st} October, 2023 at 11:00 hrs. along with necessary documents in a sealed envelope superscribed with the words "BIDS FOR E-WASTE. TO BE OPENED ON 01^{st} Nov, 2023" by THE ADDRESSEE ONLY" addressed to "Sr. Accounts Officer, EDP Cell, O/o The Pr. Accountant General(A&E) Meghalaya, Shillong" and drop personally in the tender box kept at the Ground Floor, Record Section of this office.

Any application received after the last date and time of submission will be rejected.

6. CONTENTS OF THE SEALED ENVELOPE:

The sealed envelope should contain the following: -

- Application bid form (Annexure-II)
- ii. Self attested copy of valid registration certificate for being authorised and registered as a Dismantler / Recycler / Refurbished / Producer Responsibility Organization of ewaste as per E-waste Management Rules, 2016 (as amended from time to time), with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board, etc.
- iii. The Bidder must submit a notarized affidavit on non-judicial stamp paper of Rs. 50/-(Rupees fifty) declaring that the bidder was not blacklisted during the last four (4)

years as on the date of submission of bid by State/Central Government, Government Organizations,

Government Undertakings, Public Sector Undertaking.

- iv. Self attested copy of PAN Card.
- v. Self attested copy of GST registration.
- vi. In case of non-tribal bidder, a self attested copy of valid Trading License from the Khasi Hills Autonomous District Council concerned of Meghalaya. Tribal belonging to any of the Schedule Tribes pertaining to Meghalaya, will be required to submit a self attested copy of their Scheduled Tribe Certificate.
- vii.Crossed Demand Draft / Pay Order / Banker's Cheque for Earnest Money Deposit.

In case of any of the documents are not submitted by the bidder, the O/o The PAG (A&E) Meghalaya, Shillong at its discretion may reject his/her bid/quotation.

7. GENERAL TERMS AND CONDITIONS:

- a) The application bid form (Annexure-II) shall be signed by person/persons on behalf of the bidder having necessary authorization/Power of Attorney to do so.
- b) If the space in the form (Annexure-II) is insufficient for furnishing full details, such information may be continued on separate sheets of paper, stating therein the part of the form and serial number. Separate sheets shall be used for each part and a proper reference with page number must be indicated in the main form of application.
- c) Clarifications, if any required, may be obtained from the Sr. AO/EDP Cell, O/o The PAG (A&E) Meghalaya, Shillong during Office hours before 31.10.2023.
- d) The Office is at liberty to reject or accept any or all offers without assigning any reason thereof. The decision of the office in this regard shall be final and binding. The PAG's office may also cancel this Notice Inviting Tender fully or partially without assigning any reason thereof and no liability, financial or otherwise, will be borne by the office in this regard.
- e) The inspection of the goods can be carried out by the prospective bidders or their representatives in the O/o The PAG (A&E) Meghalaya, Shillong in all working days between 11:AM to 4:00 PM up to 30.10.2023.
- f) Any taxes as levied and applicable shall be paid by the successful bidder.
- g) The e-waste items proposed will be sold "AS IS WHERE IS BASIS" and will be deemed to have been on the understanding that the bidder has satisfied fully himself/herself/themselves about the conditions, quality, etc., of the same.
- h) The successful bidder will be required to make full payment of bid by way of crossed Demand Draft/Pay Order/Banker's Cheque from any Commercial Bank in favor of the "Pay and Accounts Officer Shillong. O/o The PAG (A&E) Meghalaya, Shillong ", within 7(seven) days after issue of letter of acceptance by the O/o The PAG (A&E) Meghalaya, Shillong on failure to do so, the Office shall have the right to forfeit the entire Earnest Money deposit amount of the bidder.

- i) and dispose the items to an alternate bidder as decided by, Secretary, NEC and will be final.
- j) The successful bidder shall be required to lift all the items to his/her premises within 7(seven) days after the payment of the quoted amount (EMD amount will be adjusted with the quoted value for the successful bidder). On failure to do so, the Office shall have the right to forfeit the entire Earnest Money Deposit amount of the bidder and dispose the items to an alternate bidder as decided by O/o The PAG (A&E) Meghalaya, Shillong andwill be final.
- k) The Successful Bidder will have to make their own arrangement at their own cost for loading and transportation of the materials/items to their respective destination. There will be whole responsibility of the Successful Bidder for any damage / mishap of labors / workers engaged during the loading of materials within the Office Complex.
- I) No damage shall be caused to the property of the Office Complex in the premises while removing the e-waste items. Any loss/damage to the property of the office or injury or personal accident suffered by any person due to negligence or action of the Successful Bidder or his authorised worker/supervisor, will be borne Successful Bidder.
- m)The Successful bidder should follow the procedure under various Laws / Acts / rules in force from time to time in connection with disposal of e-waste.
- n) No bid shall be accepted after the due date and time. If the due date happens to be a holiday, the bid shall be opened on the next working day at the same time notified as above.
- o) Bids/quotations will be opened on 01.11.2023 at 11:00 hrs. If the opening date happens to be a holiday, the bid shall be opened on the next working day at thesame time at Conference Hall, O/o The PAG (A&E) Meghalaya, Shillong.
- p) The rate quoted should be inclusive of all taxes, miscellaneous charges like transportation, labour or any other expenses, etc.
- q) The bids shall be examined by the O/o The PAG (A&E) Meghalaya, Shillong . If more than one bidder has submitted offers, the bid comparison shall be made as per the quoted rate. The rate quoted by the bidder which is found to be the highest shall be selected by this Office provided that such rate is, in the opinion of the Office, reasonable. In case of a tie, the winning bid may be decided by draw of lots or at the discretion of the Office.
- r) In case only one bidder quotes without competition from other bidders, the Office may at its discretion select that particular bidder provided that the quoted rate is, in the opinion of the Office, reasonable.

- s) In the event of any question, dispute or difference is arising between the Office and the bidder relating to any matter arising out of or connected with this tender, the decision of the office shall be final and binding on both the parties.
- t) Legal jurisdiction for any disputes, if arise, is subject to exclusive jurisdiction of competent courts in Shillong (Meghalaya) only.
- u) Bidder should specially take note of all addendum/corrigendum related to this auction which will be published at the office websites (https://cag.gov.in/ae/meghalaya/en) and no separate intimation for the same will be issued by the Office.
