- 10. AEs should not be simply copy pasted in the Draft Report without any redrafting.
- 11. The audit observation need not be reiterated while writing the rebuttal and rebuttal should be very 12. One third margins should be maintained for the draft LAR with double line spacing.

- 13. Interact with FAW sections (including RAO/Abids) who are conducting the Voucher Audit; 14.Study the previous Inspection Reports, examine the PMV Register, review the outstanding paras if any and verify the G.O. Register in Editing section, verify the previous Audit Reports and
- 15. Any important point noticed during the course of audit may be brought to the notice of Sr.AO,
