- 4. Audit Team have to conduct the Desk Study for 2 days for the units assigned to them for Audit. Time consumed for Desk Study will be adjusted from the total time given for the audit of units and party will start audit in the unit after approval of Desk Study from Deputy Accountant General.
- 5. For Desk Study, voucher wise VLC data is to be arranged in ascending/descending order in Excel Sheet and Risk Analysis is to be done on the basis of value of Vouchers item-wise.
- 6. The audit team have to submit separate inspection reports for all units.
- 7. During audit of DPO (Estd) units, parties have to sample 10 schools and send DAG/AMG II for approval.
- 8. Shri Sanjoy Kumar Srivastava remained attached to Headquarter for hyperlinking KDs of SSCA from 23.02.2023 to 26.02.2023. He availed transit from Bodhgaya to Patna on 22.02.2023 (Evening) and from Patna to Bodhgaya on 27.02.2023 (Morning).
